**MINOR PARTICIPANT WAIVER, RELEASE,
INDEMNIFICATION OF ALL CLAIMS & COVENANT NOT TO SUE**

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in its entirety. By signing this agreement, you give up your right and the named minor's right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor's participation in Camp Gan Israel Poway (hereafter "Camp Gan Israel") Programs, now or any time in the future.

Acknowledgment of Risk

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in Camp Gan Israel's activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with Camp Gan Israel's participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with participating in Camp Gan Israel and that said list in no way limits the operation of this Agreement.

Coronavirus / COVID-19 Warning & Disclaimer

Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a mean to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in Camp Gan Israel's programs or accessing Camp Gan Israel's facilities could increase the risk of contracting COVID-19. Camp Gan Israel in no way warrants that COVID-19 infection will not occur through participation in Camp Gan Israel's programs or accessing Camp Gan Israel's facilities. On behalf of myself and my child, and our heirs, successors, and assigns, I knowingly and freely, assume all such risks, both known and unknown, relating to my child's participation in Camp Gan Israel's activities arising from or relating to COVID-19, including all illnesses, injuries, damages or death arising therefrom.

Camp Gan Israel strongly recommends that all children and parents adhere to all safety and health guidelines for the prevention of COVID-19, including those issued by the California Department of Public Health and the Centers for Disease Control and Prevention.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of _____'s participation in Camp Gan Israel, I, _____, the parent/guardian of the minor named above, agree to release and on behalf of myself and the minor named above, my heirs, representatives, executors, administrators, and assigns, hereby do release Camp Gan Israel, its officers, directors, employees, volunteers, agents, representatives and insurers ("Releases") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, the named minor, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Camp Gan Israel on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of Camp Israel's facilities/equipment or participation in Camp Gan Israel's programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releases, and including, but not limited to, claims related to COVID-19.

In consideration of the named minor's participation in Camp Gan Israel, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releases from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's participation in Camp Gan Israel.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in Camp Gan Israel's participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in Camp Gan Israel and that by signing this agreement I, on behalf of myself and the named minor, HEREBY RELEASE Releases of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments, which would preclude his/her safe participation in Camp Gan Israel.

I FURTHER CERTIFY I HAVE LEGAL CAPACITY TO ACT AS THE PARENT/GUARDIAN OF THE NAMED MINOR. I FURTHER UNDERSTAND THAT THE TERMS OF THIS AGREEMENT ARE LEGALLY BINDING AND CERTIFY THAT I AM SIGNING THIS AGREEMENT, AFTER HAVING CAREFULLY READ IT, OF MY OWN FREE WILL.
